You are eligible to be a Trustee if you are:

- (a) aged over 18 years
- (b) a Registered Adult Member who is resident in New Zealand
- (c) not an employee of the Trust or of a Trust Entity

You are ineligible to be a Trustee if you can tick any of the following boxes:

- (a) are bankrupt, and/or have within the last five years been declared bankrupt;
- (b) have ever been convicted of an offence involving dishonesty¹
- (c) are or have ever been disqualified from being a director of a company registered under the Companies Act 1955 or the Companies Act 1993;

¹ as defined in section 2(1) of the Crimes Act 1961, or an offence under section 373(4) of the Companies Act 1993 (unless that person is an eligible individual for the purposes of the Criminal Records (Clean Slate) Act 2004);

- (d) are or has ever been removed as a trustee of a trust²
- (e) Become subject to a compulsory treatment order under the
Mental Health (Compulsory Assessment and Treatment) Act 1992; or
- (f) Become subject to a property order³

You are to disclose to the Trust all information about your eligibility. Failure to provide full disclosure shall entitle the Trustees to determine you as being ineligible for election.
